PLEASE TAKE NOTICE that the Texas Charter Township Planning Commission will conduct a public hearing and meeting on July 25, 2017 at 6:00 p.m. at the Texas Charter Township Hall, 7110 West Q Avenue, within the Township, to consider:

- **A Step 1 (Layout & Design) Site Condominium development project containing 30 single-family residential units. The proposed development is described by parcel no. 09-03-151-014 and is located on 30 acres of land with connection to 6th Street. The current zoning for the parcel is split between two residential districts: R-2 - Single Family Residential, and R-3 – Single and Two Family Residential. (PC Case #17-19)**

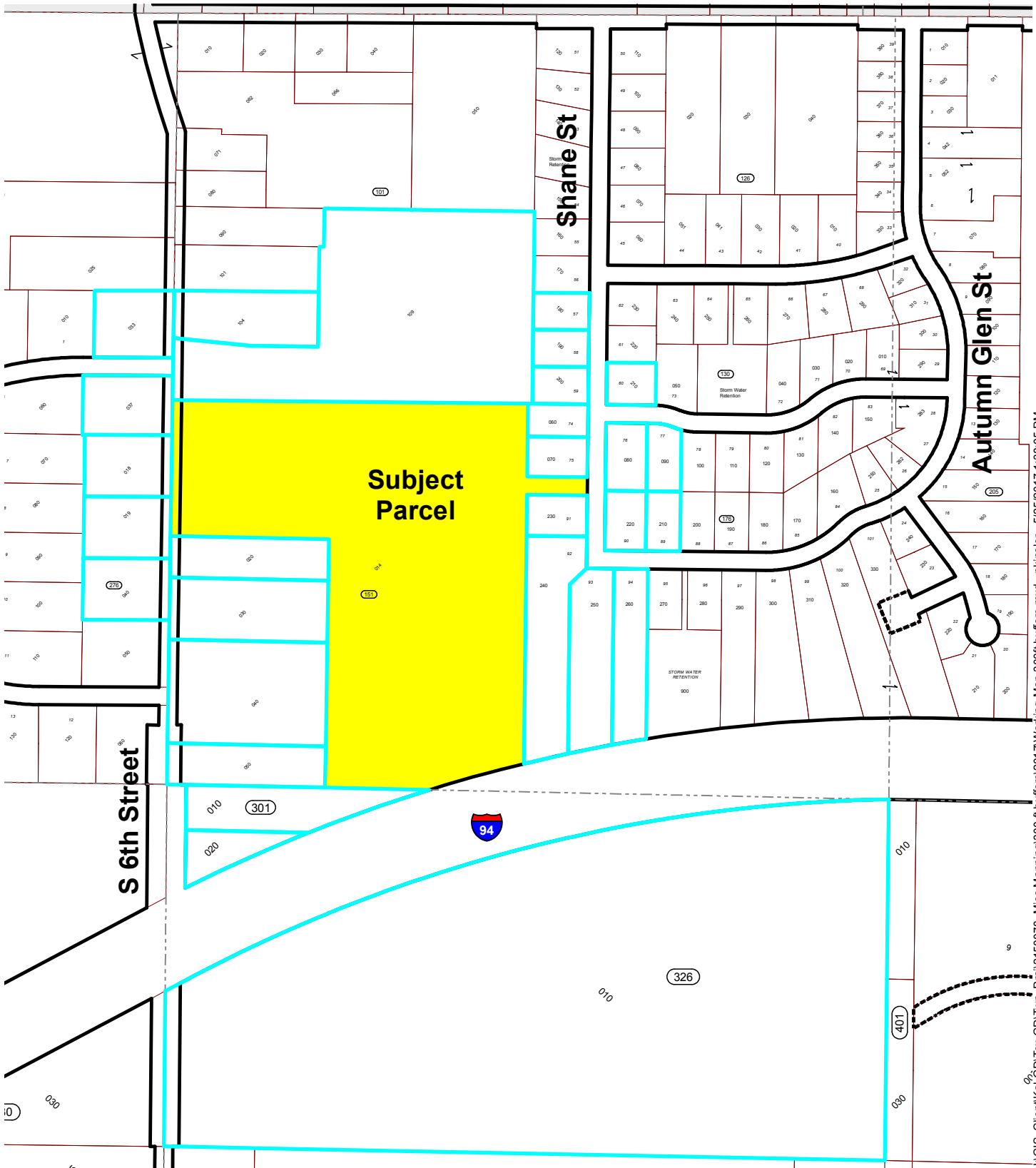

Written comments will be received from any interested persons concerning the foregoing by the Texas Charter Township Clerk at the Township Hall at any time during regular business hours up to the date of the hearing and may be further received by the Planning Commission at the hearing.

All interested persons are invited to be present at the aforesaid time and place. Texas Charter Township will provide necessary reasonable auxiliary aids and services, such as signers for the hearing impaired and audio tapes of printed material considered at the hearing, to individuals with disabilities at the hearing upon four (4) days' notice to the Texas Charter Township Clerk. 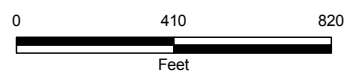
