The applicant, Kiwi & Co., seeks a Specially Designated Merchant License through the Michigan Liquor Control Commission, which requires a Special Exception Use for selling packaged liquor, beer, and wine in the CBD. 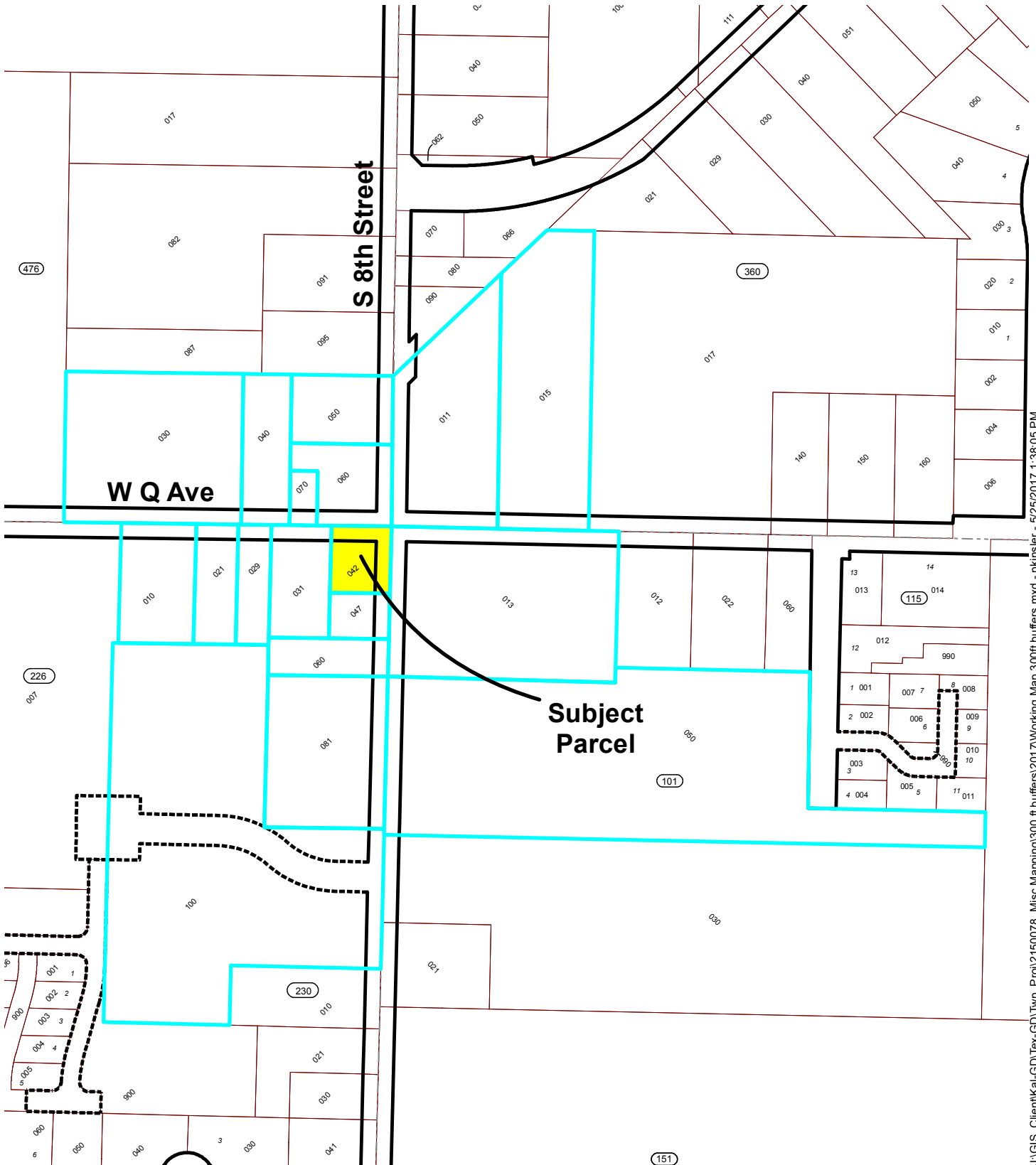
