- Such other and additional business that shall come before the Zoning Board of Appeals.

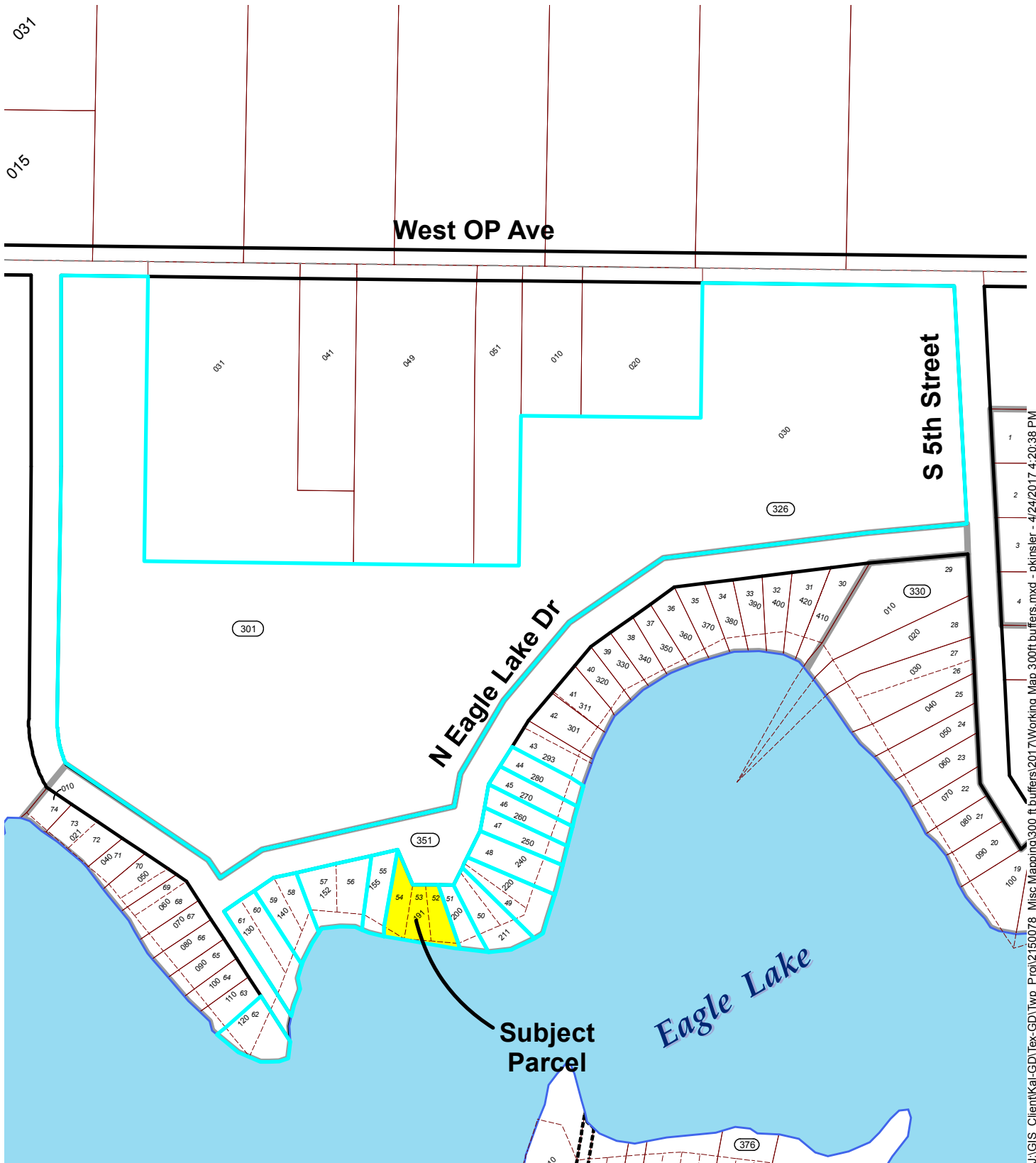

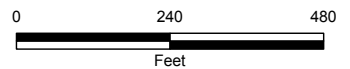
