## **TEXAS TOWNSHIP ZONING BOARD OF APPEALS VARIANCE APPLICATION AND PUBLIC HEARING NOTICE**

PLEASE TAKE NOTICE that the Texas Charter Township Zoning Board of Appeals will hold a public hearing and meeting on December 20, 2017 commencing at 6:00 p.m. at the Texas Charter Township Hall, 7110 West Q Avenue, Kalamazoo, MI 49009.

The item(s) to be considered at this meeting are:

- ZBA #17-07: Public hearing on a request by John Denny of 913 Treasure Island Dr., Parcel No. 09-16-101-030, for a variance from the R-2 District's 9-foot side yard setback requirement for lots less than 60' wide in the Texas Township Zoning Ordinance, in connection with the proposed addition of a second story and living space to the existing home.
- ZBA #17-09: Public hearing on a request by William and Judith Ford of 1381 E. Crooked Lane, Parcel No. 09-15-326-140, for a variance from the R-2 District's 12-foot side yard setback requirement in the Texas Township Zoning Ordinance, in connection with the proposed addition of 17' gable end overhangs on the north and south sides of the existing home.
- Such other and additional business that shall come before the Zoning Board of Appeals.
