If you haven't been through the Corners recently, you'll notice some big changes! Construction of the new 10,600 SQFT Township Hall is underway. Framing is in progress and all categories of work have been bid and contracted.

Investments include additional office spaces for future growth, upgraded AV components for enhanced streaming of Township meetings, additional meeting spaces to accommodate committees, and security upgrades. We are confident that this new facility will help us elevate the services provided to the township.

The current timeline for project completion is August/September 2023, but that is contingent upon availability of HVAC equipment. We remain hopeful that we'll have occupancy in fall of 2023.

## Flood Mitigation Efforts Still Underway

**Thank You to Former Superintendent Julie VanderWiere**

In October 2022, Julie VanderWiere resigned as Township Superintendent. Julie served as the Township's first Superintendent and held that position for ten years. Her contributions to the Township are innumerable and we are extremely grateful for her leadership and accomplishments over the past decade. Julie helped the Township accomplish numerous key projects, including:

- 6th Street Park: Land acquisition and Phase I development
- Texas Drive Trailway: Design and construction of Phase II trailway
- Texas Drive Park: Crowdfunding and design of Maple Hill Splash Pad
- New Township Hall Project: Oversight of feasibility study, acquisition of property, and design process with Progress AE
- Flood Mitigation: Coordination of public/private partnership and management of monumental project

**Erik Wilson to Serve as Next Superintendent**

On February 15, 2023, the Texas Township Board of Trustees unanimously approved a three-year contract with Erik Wilson to serve as the next Township Superintendent.

Erik is the current City Manager at the City of Plainwell and has served in that capacity for the past twenty years. He holds a bachelor's degree in political science and a master's degree in public administration from Eastern Michigan University.

In November 2022, the Township contracted with Walsh Municipal Services to lead the recruitment process for our next Superintendent. Eighteen candidates applied for the position and four finalists were selected for interviews by the Township Board. The finalists were:

- Adam Kline, Township Manager at Oakland Township
- Haley Snyder, City Manager at the City of Albion
- Erik Wilson, City Manager at the City of Plainwell
- Justin Lakamper, Village Manager at the Village of Edmore

Interviews were held on Monday, January 30 at 9:00 AM. During the interviews, it was apparent that Wilson was the top contender for the position. His managerial style and approach aligned with what the Board is seeking in a Superintendent, and his experience lends itself to the

#### **Michelle O'Neill Appointed as Township Board Trustee**

Following Wendy's resignation, the Township began the process of appointing a new Trustee. A public application process launched in December 2022. Public Interviews were conducted in an open meeting on January 16, 2023. ## **Texas Drive Park Swing Set** *Installation est. Spring 2023*

The Township approved the purchase of a new swing set for Texas Drive Park. The new swing set will be installed adjacent to the play structure and feature two toddler swings, two ADA compliant swings, and two standard swings.

## **6th Street Park Multipurpose Fields**

*Opening est. Spring 2023*

The Township is in the process of finalizing the multipurpose fields at 6th Street Park and anticipate having them ready for use this Spring. The last remaining improvements include the installation of goals and the striping of the fields.



## **Texas Drive Park Pavilion Mural** *Installation est. May/June 2023*

Local artist Ellen VanderMyde was recently commissioned for installation of a mural on the Texas Drive Park pavilion structure. Most recently, Ellen completed the Bike Friendly Kalamazoo mural installation on Lovers Lane (see image above). The mural will be adjacent to the Maple Hill Splash Pad and design work will begin in February 2023. The project will include a public engagement component

upgrades to the pavilion including fresh paint and signage.

## MDNR Spark Grant



In December 2022, the Parks & Trails Committee coordinated the submittal of an MDNR SPARK grant application for the construction of the restroom facility, pavilion, and play structure at 6th Street Park. The SPARK grant is a new initiative using state ARPA dollars to help improve and redevelop existing public recreation spaces. Unfortunately, the Township was not awarded funding during Round 1 - however, the Township Board does plan to move forward with design of the restroom facility and our hopeful construction can begin in mid-to-late 2023.

## Flood Mitigation Long-Term Project

**\$1.7M FEMA Grant Awarded | Permit Issued**

project and issued the permit for construction. The Township has received \$1.7 in FEMA grant funds to assist with funding the construction of the long-term project, this is an increase of nearly \$1M over the initial award of \$0.7M. The construction drawings have been finalized and were released for bidding on February 1st. Bids are expected back on March 1. At this time, the Township and Drain Commission anticipate that construction will start this year, however, the timeline will be clearer after bids have been submitted and reviewed. While the additional FEMA grant monies will help with funding the project, there is a strong likelihood that additional funds will be needed. The Township has budgeted funds to contribute to the project; the remaining project cost will be shared by the property owners in the special assessment district that was established by the Kalamazoo County Drain Commission in 2021. The Drain Commission will begin preparing the assessment roll for the district once we have final bid results. A public hearing will be held as part of the assessment roll process and property owners in the district will receive a mailed notice from the Drain Commission in advance of that hearing. We will communicate that date as soon as it becomes available.

While there is still much work remaining, the project is moving forward as quickly as possible and we would like to thank EGLE, Prein & Newhof, the Kalamazoo County Drain Commission, the Flood Task Force, and the Lake Associations for their tremendous work and support over the past several years. We are confident in the final project design and look forward to the start of construction.

## Mandatory Sewer Connection

**Deadline to Connect Extended to October 1, 2023.**

It's been over five years since Sewer Ordinance #328 was approved and we are nearing the five-year deadline (April 1, 2023) for connection to the public sanitary sewer system if a lead is located within 200' of an existing structure originating sanitary sewage.

Progress has been good. Of 4,090 parcels with sewer available there remains 137 (3.3%) who have not connected. Many of you have participated at our meetings and we have learned the variety of reasons you do not want to connect or what has limited your ability to connect. While it is unlikely the Ordinance requirement to connect will be amended, there are changes the Board is considering and has implemented facilitating the connection.

On February 13, the Board adopted a resolution allowing for the following:

- An extension to the mandatory connection deadline. The new deadline to connect is October 1, 2023.
- Reduced the cap on the connection fee financing agreement to 5.5% from 8%.
- Any household that previously signed a 2023 agreement will have their interest rate lowered to 5.5%.

During February/March, the Board will explore our ability to provide the following:

- Will the township be able to finance an individual installation at a nominal interest rate?
- Will there be parameters for deferments and exemptions, up until a private system fails?

- based deferment?
- Waivers / deferments based on household income?
- Identify parcels that may not be allowed deferments or exemptions. For example,
  - Riparian: Improved parcels that remain unconnected: Crooked (7); Eagle (12); Pretty (3)
  - Parcels in the Wellhead Protection Zone
  - Parcels within 1,320' distance of named water bodies.

The Board understands that the changes in the economy over the past year have greatly affected residents' ability to fund their connection. There is also an increased demand for contractors which has limited their availability.

However, the Board also considers that the State and area municipalities utilize an 18-month time frame, and your Board hoped the longer five-year term would allow residents to better plan.

## Curbside Bulk Item Collection

### Program to Continue in 2023

In 2023, Texas Township will once again be partnering with College Hunks to offer one curbside bulk item collection service. The township will be divided into four zones of ~1,500 homes per zone. Each zone will have five designated days for collection. The zone boundaries will remain largely the same as in 2022.

#### Service Availability

This service will be available for single-family homes and condominiums located within the Township. It will not be available for vacant parcels, commercial or industrial buildings, apartments, or manufactured home communities.

#### How it Works

Residents can place accepted items at the curb the Friday-Sunday prior to the start of collection in their zone. College Hunks will pick up the items during the designated collection period (within five days) and recycle or dispose of the items.

#### Schedule

Collection will begin on Monday, April 24. Please view the schedule below:

Zone 2 - Collection Begins: Monday, May 1  
Zone 3 - Collection Begins: Monday, May 8  
Zone 4 - Collection Begins: Monday, May 15

## Riparian Ordinance Update Project

On Wednesday, February 15, the Planning Department held a public listening session for the purpose of learning more about current riparian challenges and discussing the upcoming riparian ordinance process. There were approximately 25 in-person attendees and over 30 Zoom attendees. We'd like to thank all who attended and provided input on this process.

The Township has been discussing the need for updates to the current riparian regulations since before the flooding in 2018, when groundwater and lake levels did not recede following rain events as they had in years past. Now that the Township is in the home stretch with final permitting and eventual construction of a long-term solution, the Township Board has directed the Planning Department and Planning Commission to resume work on updating riparian regulations to protect lakes, ponds, and streams within the Township, in addition to centralizing the regulations within the Zoning Ordinance for simplicity.

This is a multi-month process with the next step being the likely circulation of an online survey to collect additional information and validate feedback received at the listening session. There is also a strong possibility of a community workshop following the survey. The continued process is focused on engagement - it is unlikely that the Planning
