



**NOTICE OF PUBLIC HEARING
ON THE GENERAL FUND, FIRE OPERATING FUND, BUILDING INSPECTION FUND,
ROAD AND BRIDGE FUND, DOWNTOWN DEVELOPMENT AUTHORITY FUND,
CAPITAL IMPROVEMENT FUNDS, WATER & SEWER FUNDS, TOWNSHIP HALL CONSTRUCTION
AND DEBT SERVICE FUNDS, LONGHORN DRIVE CONSTRUCTION FUND,
AND SPECIAL ASSESSMENT DISTRICT BUDGETS FOR THE 2026 CALENDAR YEAR**

TO: **THE RESIDENTS AND PROPERTY** owners of the Charter Township of Texas, Kalamazoo County Michigan, and all other interested persons.

PLEASE TAKE NOTICE that the Township Board of the Charter Township of Texas has estimated that the total cost and expenses of the general operation of the Township, for the 2026 calendar year of the Township will be **\$4,362,373**.

PLEASE TAKE FURTHER NOTICE that the Township's original charter millage was 1.0 mill and said charter millage was reduced by law to **.8266** mills in 2025.

PLEASE TAKE FURTHER NOTICE that the fire department voted millage is **.9741** mill in 2025.

PLEASE TAKE FURTHER NOTICE that the anticipated revenues for the Township including the aforesaid millage of **.8266** mills, manufactured home taxes, and state shared revenues, miscellaneous fees, fines, and other revenues for use in funding the general fund budget totals **\$4,194,778**.

PLEASE TAKE FURTHER NOTICE that the Township Board will conduct public hearings on the budget for the foregoing estimated costs, expenses, and proposed levy of the **.8266** mills for General Operating and **.9741** for Fire Improvement at the Texas Charter Township Hall, 7227 West Q Avenue within the Township on November 10, 2025, commencing at 6:00 p.m.

PLEASE TAKE FURTHER NOTICE that the Township Board will also conduct public hearings on the foregoing estimated costs, expenses, and capital charges on the proposed budgets for the Capital Improvement Funds, Building Inspection, Fire Operating, Downtown Development Authority, Sewer Fund, Water Fund, New Township Hall Construction Fund, Longhorn Drive Construction Fund, General Debt Service -Township Hall, Opioid Settlement Fund, Special Assessment Districts: Eagle Lake Maintenance #1 & #2, N. Eagle Lake Drive Road Maintenance; Crooked Lake Maintenance #1 & #2, Treasure Island Road Maintenance, Road & Bridge Maintenance, Texas Corners Corridor & Pathway Enhancement, CCTA, and Street Lighting Fund.

PLEASE TAKE FURTHER NOTICE THAT THE PROPERTY TAX MILLAGE RATE PROPOSED TO BE LEVIED TO SUPPORT THE PROPOSED BUDGET(S) WILL BE A SUBJECT OF THIS HEARING.

PLEASE TAKE FURTHER NOTICE that a copy of the proposed budget will be on file and available for public inspection at the office of the Township Clerk at the Township Hall during regular office hours of regular business days from and after the publication of this notice, and until and including the day of said hearing and will further be available at said hearing.

PLEASE TAKE FURTHER NOTICE that Texas Charter Township will provide necessary, reasonable auxiliary aids and services at the hearing to individuals with disabilities upon reasonable notice to the Texas Township Clerk of the need for same. Individuals with disabilities requiring auxiliary aids or services should contact the office of the Township Clerk by writing or calling the undersigned Clerk.

All interested persons are invited to be present at the aforesaid time and place to participate in the discussion upon said proposed budget and the levying of the **.8266** mills for general operating and **.9741** mills for fire improvement.
